- Criteria
- Decline or Pre Approved
- ➤ Vetting
- Approval of Decline
- Payment
- Scheduling & Collection
- Monitoring





How to select, onboard

- ➢ Set Criteria
- > Available on the website

Criteria includes:

- Cooking 3- 5 days a week
- BO must be cooking
- ➢ NPO registration
- Demographics





Common Reasons for Decline

- Cooking less than 3 days
- ➢ Feeding less people 50 is the minimum
- ➢ Kitchen, storage and cooking equipment
- Incorrect or untraceable address
- Address untraceable
- No organisation boards
- ➢ New organisation − less than a year
- Demographics not completed or incorrect





VETTING

Why is it important to vet?

- > To see if the organisation exists
- Verify information on the application
- Confirm operations
- Check if the premises meet the standard- dedicated facility. Kitchen, storage, staff and database for beneficiaries
- Check if the place for eating is more dignified and cleaner for people to eat
- Verify the address





Monitoring

Why is Monitoring important

- Monitoring is done 4 times a year
- We do unscheduled visits
- We check if the BOs still exist and still cooking
- Verify of the donated food is reaching the beneficiaries
- Provide support
- To convey information or any updates

Non-compliance

When does a BO become Non-compliant?

- Failed monitoring BO is not open for more than 2 visits
- Not feeding for more than 2 visits
- Failure to do the survey
- Selling and giving the food to friends and families
- ➢ BO is not feeding 3 − 5 days
- Discriminating other community members
- BO fees payment





BO QUARTELY MEETINGS

- > Once a quarter
- ➢ It done virtually
- Meetings done in consultation with the warehouse
- Create a platform for sharing knowledge and experiences
- Share new information
- Welcome and introduce new BOs
- Give BOs a platform to rate our services by communicating challenges and good things about FFSA

MOBILE RURAL DEPOs

- Area identification
- > The area is rural and far from the warehouse
- FFSA delivers food to the BOs
- Coordination of the process with the branches
- Identify the depo space for the truck, BOs and safety
- Decide on the date
- NPO invitations marketing
